Flow rate may be reduced to as low as 75 gallons per minute depending upon the location of the meter installation. Standard mechanical connection size to backflow preventer is 2-inch female thread. It is the responsibility of the applicant to provide the appropriate fittings for the connection to the backflow preventer. Only MCPW personnel shall operate the hydrant and associated appurtenances. Please allow 3-5 business days for installation.
